<b>MINIMUM NOTICE SERVICE FEES</b>	
<b>Less than 48 hours' notice</b>	Add \$10/hour to applicable interpreting fee
<b>Less than 24 hours' notice</b>	Add \$15/hour to applicable interpreting fee
<b>Less than 12 hours' notice</b>	Add \$20/hour to applicable interpreting fee
<b>ADDITIONAL SERVICES AND FEES</b>	
<b>Video Remote Interpreting</b> (1 hour minimum)	Standard interpreting rate, plus VRI/Technical fee of \$70 per job and per interpreter.
<b>Communication Access Realtime Translation (CART)</b>	\$125/hour
<b>Audio Description</b>	Contact us for quote
<b>Travel Time</b>	1-hour minimum at the same rate as the scheduled interpreting rate. If the job is cancelled within 48 hours of the appointment, we still charge for travel time due to the inability to schedule other appointments during the planned travel time.
<b>Additional Required Fees</b> (parking, tollway fees, etc.)	Amount Incurred
<b>Mileage</b>	Round trip at federal rate for jobs outside of the service provider's city of residence
<b>Late Fees</b>	Late payments for invoices are subject to service fees.

**Cancellation Policy: Cancellations within 48 business hours of the scheduled appointment will be invoiced at the appropriate rate. Same day cancellations may incur full charges including mileage.**

**Connections Observed Holidays: New Year's Day, Martin Luther King Jr. Day, President's Day, Memorial Day, Juneteenth, Independence Day, Labor Day, Thanksgiving, Day after Thanksgiving, Christmas Eve, Christmas, New Year's Eve.**
